Breakout Groups

- Outreach- Efforts are underway through community events, social media, and QR code virtual events, but we are currently missing collaboration with the Community School Coordinators. By partnering with them, we can build resources and establish them as the central point of contact, rather than relying on multiple agencies. The impacts of covid including isolation and mental health had a significant effect on the youth.
- After school- An innovative club for teens within walking distance, with a dedicated counselor on-site, would provide valuable support. However, transportation would be needed to access the Worton Community Center, Innovation Hub, and the library. KCPR would expand programing for teens.
- Implement housing and entrepreneurship support, along with target zoning reform, to attract long-term employers and draw in telecommuters.

Partner Updates

- There are three vacant seats on the KCLMB board that must be filled by June 2025. Terrance has resigned, and Samantha is no longer working for the Kent Family Center. If you have any suggestions, please let Van or Rosie know.
- Brighter Day Funds, administered by the Kent County Local Management Board's Local Care Team, are available to families in need. For families outside the Local Care Team, the maximum award amount is \$300. Applications are accepted on a rolling basis, subject to fund availability.

Systems of Care: Building Stronger Communities



What is a System of Care?

A system of care is a coordinated network of services and supports organized to meet the physical, emotional, and social needs of children, youth, and families.

- Originates from the Substance Abuse and Mental Health Services Administration.
- Focuses on individualized, family-centered, culturally competent care.

Family Driven, Youth Guided

Families and youth are equal partners in decision-making.

Community Based

Services are avialable within the community and leverage local resources

Culturally Competent

Competent Services respect and respond to the cultural backgrounds of individuals.



Strengthening **Systems of Care**

SAMHSA created a strategic framework based on a study of effective strategies for expansion and research on making and sustaining systematic changes. The framework includes five "core strategy" areas." (Stroul, et.al., 2015).

Developing or expanding services and supports based on the system of care philosophy and approach.

Continue to increase collaboration across agencies through shared work and building a data-sharing network.




Advocacy


